The Monte Vista School District is requesting proposals for all or any one of the following categories in accordance with the Schools and Libraries Eligible Services List for Funding Year 2017

Broadband Internal Connections Components

1.
 1. routers (1 or more)
 2. switches (5 or more)
 3. wireless access points (10 or more)
 4. antennas, cabling, connectors & related components used for internal broadband connections (as needed to support items in this list)
 5. racks (1 or more)
 6. wireless controller systems (2 onsite, more if necessary)
 7. firewall services & components
 8. uninterruptible power supply (UPS) / battery backup (1 or more)
 9. caching servers (up to 4)
 10. software supporting eligible components used to distribute broadband throughout school buildings

Note: The Monte Vista SD may work with the bidder to determine actual number of components needed.

Eligible Managed Internal Broadband Services

The operation, management and monitoring of eligible broadband internal connection components are owned by the School District.

Basic Maintenance of Eligible Broadband Internal Connections

The Monte Vista School District is requesting proposals for all or any one of the following categories in accordance with the Schools and Libraries Eligible Services List for Funding Year 2017

1. Repair and upkeep of eligible hardware
2. Wire and cable maintenance
3. Configuration changes
4. Basic technical support including online and telephone based technical support
5. Software upgrades and patches including bug fixes and security patches

Internet Service

Monte Vista School District is requesting proposals for internet service for our public school district in accordance with the Schools and Libraries Eligible Services List for Funding Year 2017. The district currently has fiber optic cables serving all buildings with service emanating from our central hub located at 345 East Prospect Avenue, Monte Vista Colorado.

1. Minimum band width of 150Mbps
2. Maximum band width of 750 Mbps
3. Desire multi-year agreement with flexibility in the agreement to move bandwidth high in any given year depending upon usage needs.
