## Meeting of August 16, 2018

**Superintendent Report.** Mr. Webb reported a Paraprofessional for the 2018-19 school is needed because of the higher than expected enrollment in the Kindergarten. Various options are being considered for the Middle School Behavior Interventionist for this school year. There is an upbeat atmosphere in both the Middle School and High School as new staff and returning staff arrive to prepare for the new year. Enrollment is looking good for this year and the fund balance is stronger than expected. Mr. Webb is working with the maintenance department about options for reducing electrical usage throughout the District.
